Notice is hereby given that the Franklin County Planning Department will conduct a public hearing for the FY 2021 Community Development Block Grant (CDBG) Program on Wednesday, October 6th, 2021 at 3:00 PM prevailing time at the Franklin County Administration Building Board Room, 272 N. Second Street, Chambersburg, PA. The meeting is open to all residents, groups, and organizations. The Administration Building Board Room is accessible to persons who are physically disabled.
