# Accomplishments/Highlights

- Human Services Block Grant - we have successfully been able to maintain all of the 12 voting member seats for the Committee. Composition - 6 members of lived experience and 6 members of those with community expertise. Our Block Grant Committee members are always fully engaged and eager to learn and help.
- Successful hiring and onboarding of the new VA Director to assist in leading the department to expanded opportunities with assisting Veterans to connect with benefits.
- Successful collaboration with the Grants department to plan and implement a Sequential Intercept Model (SIM) training /symposium to review current accomplishments, goals, and future planning.
- Ongoing collaboration and partnership with the Courts division to assist with and participate in special projects - Autism and Spectrum education and preparedness for court: AOPC planning activities related to BH and the forensic/court systems.
